

# State Licensing Requirements

The state of Idaho has the following training requirements: Cosmetology 1600 hours, Esthetics 600 hours, Nail Technology 400 hours, Barbering 900 hours, Instructor 1000 hours if less than 3-years' applicable work experience/500 hours if less than 5-years' applicable work experience.

The following information is regarding other states' requirements for licensure in the same fields as those offered at Aveda Institute Boise and Aveda Institute Twin Falls. We encourage all students/graduates that are considering transferring their license to another state to first pass the state board exams and become licensed in Idaho. This will make for a smoother transfer of licensure to another state. Please check with the local governing agency for the state you are wanting to transfer to, for the latest information about what will be required to do so.
